Electronic Tax Bill Enrollment

Disclaimer

The Collier County Tax Collector's Electronic Tax Bill Service was created to increase efficiency and provide an electronic method to deliver property tax bills. Under Florida Law, email addresses are public records. If you do not want your email address released in response to a public records request, do not register for E-Bill service.

Click I ACCEPT to acknowledge you have read and understand the disclaimer.

If you change your email address you will be required to complete another enrollment form.

If our office is unable to deliver your tax bill electronically for any reason you will be automatically cancelled from the electronic tax bill service and a paper tax bill will be mailed to you.

If at any time you wish to cancel your electronic tax bill service and resume paper delivery please unsubscribe. If this change is made prior to September 30th it will take effect for the current tax roll. If not, it will take effect the next tax roll year.

Terms and Conditions

1. Acceptance of Agreement. Your use of this site indicates your full agreement to all terms and conditions listed
2. Disclaimer: The eBill service is a free service provided by the Collier County Tax Collector, and is solely intended as an aid to remind participants to pay property taxes. Taxpayers are not relieved of the responsibility of timely payment of property taxes as a result of any failure of the Tax Collector to forward these notifications. Penalties for delinquent payments will be imposed regardless of the taxpayer's subscription to this service or any failure of this service. This service is provided without warranty or representation of any kind. The Tax Collector shall not be liable for any loss or inconvenience caused by the participation of subscribers or the failure of the service to provide timely notification or even the total failure of the service to provide any notification at all, whether or not the Tax Collector is at fault.
3. The Tax Collector will rely on the email address provided by the taxpayer. Should the taxpayer change their email address, or should the email address cease to be correct the taxpayer must submit a new electronic tax bill registration or revoke the existing E-Bill service and request the Tax Collector to send paper bills. It is the responsibility of the taxpayer to maintain a current email address with the Tax Collector.
4. Under Florida Law, email addresses are public records. If you do not want your email address released in response to a public records request, do not register for E-Bill service.

Select if you are either the property owner or authorized by the owner and then click SUBMIT. You will see the following screen.

You will now receive a confirmation email. Please click the link in this email to verify your address and complete your eBill signup.

Within a few minutes you should receive an email which will include a link that will confirm your enrollment in the electronic bill system. If you do not receive the email be sure to check your "SPAM" folder in your email program to make sure it was not mistakenly delivered there. After clicking the link in the email you should see something similar to below.
